

FUNdraising for Special Touch INDEMNITY AND RELEASE WAIVER OF LIABILITY

This Release waiver is ONLY for those fundraising completely online family members in the same household sharing a book. ALL OTHER participants SHOULD complete the waivers located in their fundraising book.

In recognition of the risk of injury while participating in the FUNdraising for Special Touch event activity (the "Event"), and as consideration for the right to participate in the Event, I hereby for myself, my heirs, executors, administrators, assigns, or personal representatives knowingly and voluntarily enter into this waiver and release of liability ("Agreement") and hereby waive any and all rights, claims or causes of action of any kind whatsoever arising out of my participation in the Event, and do hereby release and forever discharge Special Touch Ministry, Inc. and its affiliates, managers, members, agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns, the event site and its agents, attorneys, employees, volunteers, heirs, representatives, predecessors, successors and assigns and all sponsors and/or beneficiaries of the Event from any and all liability, claims, demands, damages, actions, or causes of action now existing or which hereinafter may arise as a result of my participation in the Event, whether any injury is caused by the negligence of the Hosts, the negligence of myself or third parties, the conditions of the facility or any other cause.

I attest that I am physically fit and if under the care of a licensed medical doctor, have been physically released to participate in this event. For safety purposes, I agree to refrain from using headphones, cellular phones, or any other device, which may impair my actions during the event.
